Dear parent/guardian and student:

As approved instructors of the Arlington Music Enrichment Program (AMEP), Lamar voice instructors follow the guidelines set by the school district. Please read the following information, sign the agreement at the bottom, and return this paper with the AMEP application form:

- The standard rate for each 25-minute lesson is **\$17.00 per lesson**. Monthly statements will be sent or handed to the student for advance payment in the final monthly lesson. Payments may be mailed or brought to the instructor at school. Make your check payable to the student's instructor, not Lamar High School or Lamar Choir.
- Attendance policy:**
 - Students must sign the Attendance Record each time they receive a lesson.
 - The student will receive the AMEP instructor's phone number at their first lesson. Students are to notify the instructor **at least 24 hours in advance** if they wish to be excused from a scheduled lesson. This policy includes absences due to school activities. If you have a morning emergency, contact the instructor as soon as possible. If the instructor cannot be reached, contact Toni Worley, Nelson Romo, or Greg Haugen.
 - If a student is absent and the instructor has not been notified beforehand, the student has an unexcused absence. After two consecutive unexcused absences, the parent/guardian(s) and the instructor will discuss if the student is going to continue lessons.
 - A student who receives an **unexcused absence will be billed for that lesson. Students with scholarships are responsible for the full cost of a lesson missed due to unexcused absence.**
 - Excused absence lessons will be rescheduled at the instructor's discretion and convenience.
 - If a student is in class but does not have his/her voice the day of a lesson, s/he will still meet and work on skills that do not require singing.
 - When notified of an absence, the instructor may give other students the opportunity to take that time slot even if it is not his/her normally scheduled day or time.
 - If the instructor is unable to teach on a scheduled day, s/he will notify the student(s) and/or the choir director in advance. A make-up day will be arranged.
- Students can expect to learn or improve the following: sight-singing, vocal technique, vocal health, music term recognition, performance practices, performance etiquette, audition material selection and technique, different music style performance and repertoire, and how to practice independently.
- Students are encouraged and expected to participate in the 9th and 10th Grade Honor Choir or TMEA All State auditions, the Winter Recital, Solo and Ensemble Recitals and Contest, and the Spring Recital. However, lessons are not limited to these opportunities.
- Students will have weekly assignments and are expected to practice regularly between lessons.
- Students are expected to take responsibility for anything missed in choir class during the 25 minute lesson.
- Students are expected to bring their music, a pencil, and any other assigned materials to every lesson.
- Students enrolled in AMEP are expected to continue lessons through May. If a student must cancel lessons prior to May, the parent/guardian must give two weeks written and verbal notice to the instructor.
- There is an **Accompanist Fee of \$10** due by January for those participating in Solo and Ensemble Contest.
- Each instructor may have additional policies. Once a student has been assigned a teacher, that student may receive more information.
